ORDER GRANTING MOTION FOR EXTENSION OF TIME

On January 15, 2026, Union Electric Company d/b/a Ameren Missouri filed the above-referenced application. Ameren Missouri wishes to construct a 161 kV switching station and associated facilities, known as the Vanduser Switching Station, in Stoddard County, Missouri.

The Commission ordered its Staff to file a Recommendation or alternative pleading no later than February 17, 2026. On February 17, 2026, Staff filed a Motion for Extension of time, asking for another 30 days to review discovery. The motion indicated that Ameren Missouri was contacted, and that Ameren Missouri does not object.

The Commission finds the request reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a Recommendation or an alternative pleading no later than March 19, 2026.
2. This order shall be effective when issued.
