On January 29, 2026,¹ Staff filed *Staff Report and Recommendation* (Report). The Report stated that Staff recommended approving the Certificate of Convenience and Necessity, subject to 17 conditions.

On February 9, Missouri-American responded, objecting to the second, seventh and eighth conditions, but not objecting to the others. On February 17, Staff filed a *Motion for Extension* requesting an extension to February 23.

The Commission finds this request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff's Motion for Extension is granted. No later than February 23, 2026, Staff shall file a response to Missouri-American's response to Staff Report and Recommendation.
2. This order is effective when issued.
