**ORDER GRANTING FILING OF SUPPLEMENTAL APPLICATION**

On November 11, 2025, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application requesting that the Commission approve its acquisition of the sewer system assets of Swan Lake Estates, LLC (Swan Lake). The Swan Lake sewer system serves two mobile home parks in Lafayette County, Missouri – Swan Lake Estates and Bates City Mobile Home Park.

On January 29, 2026, Confluence Rivers filed a *Motion for Leave to Supplement Application* (Motion). The Motion explained that Confluence Rivers’ application filed in November only contemplated the purchase of Swan Lake’s sewer system and did not include the purchase of any portion of Bates City Mobile Home Park’s wastewater collection system. The Motion stated that the Missouri Department of Natural Resources (DNR) indicated that Bates City Mobile Home Park’s wastewater collection system is considered connected (by lift station) to the Swan Lake sewer system. Consequently, Confluence Rivers stated it reached an agreement to purchase the Bates City Mobile Home Park’s lift station and downstream collection lines at issue, and the Motion requests to supplement the November application by adding this purchase.

The Commission set a time for responses, but none were filed.

The Commission finds the unopposed request to supplement the November application to be reasonable and will grant it.

**THE COMMISSION ORDERS THAT:**

1. The Motion is granted. The application of Confluence Rivers is supplemented as set forth in the Motion.
2. This order shall be effective when issued.
