**TUK’S RESPONSE ORDER DIRECTING FILING**

**COMES NOW** TUK LLC (TUK) and, in response to the Missouri Public Service Commission’s (Commission) Order Directing Filing, states as follows:

1. On June 8, 2015, The Commission issued its Order Directing Filing, wherein it directed that any party wishing to respond to the Office of the Public Counsel and TUK, LLC filing, should do so by June 11, 2015.

2. The Order Directing Filing indicated that the “Office of the Public Counsel responded to the recommendation and requested an additional requirement that TUK LLC file a new rate case within 18 months of the effective date of an order setting rates.”

3. After discussion with Counsel for the Office of the Public Counsel (OPC), it is the undersigned’s understanding that OPC intends for its rate case filing requirement be an alternative to (or instead of) Staff’s proposal for a rate review between 12-18 months after the effective date of an order in this case.

4. TUK does not object to either the rate review proposed by the Staff or the rate case filing proposed by OPC. However, it does object to participating in both. There is no need for a company the size of TUK to be subjected to the discovery demands of an audit twice in a six month period.

**WHEREFORE**, TUK respectfully requests that the Commission consider this response and, thereafter, grant TUK permission, approval and Certificates of Convenience and Necessity authorizing TUK to install, acquire, build, construct, own, operate, control, manage and maintain water and sewer systems for the public within the area identified in Staff's Recommendation.
