RECOMMENDATION TO APPROVE TARIFF

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and for its recommendation that the Commission approve the tariff sheets filed by Missouri-American Water Company (“MAWC”) states the following:

1. On February 19, 2026, MAWC filed revised tariff sheets, as authorized by the Commission’s February 19, 2026 *Report and Order*.
2. The tariff sheets bear an effective date of March 21, 2026, and have been assigned Tracking Nos. JW-2026-0114 and JS-2026-0115.
3. On February 19, 2026, MAWC filed a *Motion for Expedited Treatment*, requesting that the Commission approve the tariff sheets to take effect for service rendered on or after March 1, 2026, or as soon thereafter as is reasonable.
4. On February 20, 2026, the Commission issued its *Order Directing Filing on Compliance Tariff Sheets*, directing Staff to file a recommendation on MAWC’s revised tariff sheets no later than February 23, 2026.
5. Staff has reviewed the tariff sheets submitted by MAWC and recommends their approval.

WHEREFORE, Staff respectfully submits this Staff Recommendation to Approve Tariff, and respectfully requests the Commission approve the tariffs filed by MAWC and grant such other and further relief as is just in the circumstances.


