## ORDER APPROVING TARIFF SHEETS

Issue Date: February 24, 2026

Effective Date: March 1, 2026

On February 19, 2026,<sup>1</sup> the Commission issued its *Report and Order* authorizing Missouri-American Water Company (MAWC) to establish Water and Sewer Infrastructure Rate Adjustment (WSIRA) rates for water and sewer service. That order rejected the previously filed tariff revisions and directed MAWC to file tariff sheets in compliance with the Commission's order.

On February 19, Missouri-American Water Company (MAWC) filed revised tariff sheets to recover WSIRA revenues consistent with the Commission's order. The tariff sheets bear an effective date of March 21 and have been assigned Tracking Numbers JW-2026-0114 and JS-2026-0115. MAWC also filed a *Motion for Expedited Treatment* in which it asks the Commission to approve the tariff sheets to take effect for service rendered on or after March 1, or as soon as thereafter as is reasonable.

The Commission directed its Staff to file a recommendation on the revised tariff sheets and set a deadline for other parties to respond. On February 23, Staff filed a recommendation that the Commission approve the tariff sheets. No other parties responded.

After reviewing the tariff sheets and Staff's recommendation, the Commission finds that the tariff sheets comply with the Commission's order. In order for the tariff sheets to take effect for service rendered on or after March 1, the Commission finds it reasonable to make this order effective in less than 30 days.

**THE COMMISSION ORDERS THAT:**

1. The following tariff sheets, filed by MAWC and assigned Tracking Numbers JW-2026-0114 and JS-2026-0115, are approved to be effective on March 1, 2026:
