

**ORDER DIRECTING DEVELOPMENT OF
WILDFIRE MITIGATION PLANS**

Issue Date: February 6, 2026

Effective Date: February 6, 2026

The Commission opened this working case to examine the wildfire mitigation and preparedness of Commission-regulated utilities in the state of Missouri and to ensure that each electrical and gas corporation had a wildfire mitigation plan that could be relied upon in an emergency. Since opening this case, the Commission has received comments from utility stakeholders regarding current wildfire mitigation and preparedness, and has received comments on a series of best practices.

The filed comments and the Staff of the Commission's (Staff) ongoing discussions with the utility stakeholders have revealed that several utilities are currently in different stages of development of their wildfire mitigation and preparedness plans. To facilitate plan development for all electrical and gas corporations¹, the Commission will direct these utilities to complete draft plans by the end of the calendar year and share a final draft of the plan with Staff. The Commission will also direct the utilities to provide quarterly status updates until the time at which the final draft of the plan is shared with Staff.

Staff has also developed a series of minimum expectations and components that electrical and gas corporations shall include in their final draft wildfire mitigation and preparedness plans, provided below.

Electrical corporations

- A risk assessment of the service territory;
- A list of resources that will be used for monitoring and providing advance warning of wildfire threats;
- The use of mitigative measures to reduce the threat of facility exposure, including the use of vegetation management and inspections as a mitigative measure;
- Identification and plan of action for current system or geographic vulnerabilities;
- Inclusion of emergency response and communications plans, and training on such plans; and;
- Damage assessment following wildfire event

Gas corporations

- A list of resources that will be used for monitoring and providing advance warning of wildfire threats;
- The use of mitigative measures to reduce the threat of facility exposure;
- Identification and plan of action for current system or geographic vulnerabilities
- Inclusion of emergency response and communications plans, and training on such plans; and
- Damage assessment following wildfire event.

THE COMMISSION ORDERS THAT:

1. Electrical and gas corporations shall provide Staff a final draft copy of their wildfire mitigation and preparedness plans no later than December 31, 2026.
2. Electrical and gas corporations shall provide Staff quarterly updates on the development of their wildfire mitigation and preparedness plans, with the first update due no later than March 31, 2026.
3. The Commission's Data Center shall provide a copy of this order to all electrical and gas corporations.
4. This order shall be effective when issued.


