ORDER APPROVING COMPLIANCE TARIFF SHEETS

Issue Date: March 2, 2026

Effective Date: March 12, 2026

On January 21, 2026,¹ the Commission issued its *Order Approving Expansion of Certificate of Convenience and Necessity* (Order) granting an expansion of Missouri-American Water Company's (Missouri-American) existing Certificates of Convenience and Necessity (CCNs) for both water and sewer service.²

On February 10, Missouri-American filed tariff sheets purporting to be in compliance with the Commission's Order. Those tariff sheets were assigned Tracking Nos. JS-2026-0113 and JW-2026-0112 and have a proposed effective date of March 12, 2026.

On February 26, the Staff of the Commission (Staff) filed its recommendation that the tariff sheets comply with the Order. Upon reviewing the pleadings, the Commission

finds Missouri-American’s proposed tariff sheets comply with the Commission’s Order and will approve them. To enable the tariff sheets to become effective on the date proposed, the Commission finds it reasonable to make this order effective in less than 30 days.
