## ORDER GRANTING MOTION FOR EXTENSION

Issue Date: March 3, 2026

Effective Date: March 3, 2026

On December 15, 2025, Timber Creek Sewer Company (Timber Creek) filed a request for a rate increase. On December 18, 2025, the Staff of the Commission filed a Rate Case Timeline. Included in the timeline is the following entry; "for February 28, 2026: Deadline for Completion of Construction Projects to be Included in Case OR Agreement Filing Due Date Extended So Projects Can be Included in Case." The Rate Case timeline is contained in Commission Rule 20 CSR 4240-10.075. Given the cold weather and precipitation in the last thirty days Timber Creek says the Prairie Creek facility will not be in service by February 28, 2026, and so seeks a timeline waiver.

Commission Rule 20 CSR 4240-10.075(5)(A) provides that Staff and the utility may agree in writing that the deadlines set out in the rate case timeline be extended for up to thirty (30) days. However, in this case, Staff and the Company, with the consent of the Office of the Public Counsel seek an extension of forty-five (45) days.

Commission Rule 20 CSR 4240-10.075(15) allows for waiver of any provision of the Staff Assisted Rate Case Procedure rule for good cause. The Commission finds that providing time for the new Prairie Creek facility to be placed in service is good cause for an extension of forty-five days.

The Commission will grant the Motion for the Extension of the Timeline and order an extension of forty-five days for good cause shown.

**THE COMMISSION ORDERS THAT:**

1. The Commission will grant Timber Creek Sewer Company's request to extend the timeline of the rate case by forty-five days for good cause shown.
2. This order shall be effective when issued.
