ORDER SETTING PROCEDURAL CONFERENCE

On February 19, 2025, White River Valley Electric Cooperative, Inc. (White River) filed an Application for Approval of Designated Service Boundaries within Christian County, Missouri pursuant to RSMo 386.800.3 and 20 CSR 4240-20.045. The Commission held a prehearing conference, in which the parties stated that they agreed on all issues in the case and expected after further discussions the Office of the Public Counsel would agree to the Stipulation and Agreement previously filed.

It is now appropriate to schedule the Procedural Conference so that the parties may discuss whether the Stipulation and Agreement is agreed to or a hearing is needed, what dates would be appropriate for that hearing and what dates would be appropriate for a procedural schedule. A procedural conference will be ordered for March 11, 2026, at 3:00 p.m. by Webex.
