MOTION TO CANCEL REGISTRATION

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”) and moves for the Missouri Public Service Commission (“Commission”) to cancel the registration to provide Interconnected Voice over Internet Protocol (“IVoIP”) services in Missouri of Next Level Internet Inc., (“Next Level” or “Company”) and states:

1. On April 24, 2022, the Commission granted Next Level Internet Inc. a registration to provide IVoIP services in Commission File No. DA-2022-0277.
2. On December 7, 2023, the Company was voluntarily dissolved and was issued a Certificate of Withdrawal from the Missouri Secretary of State.
3. The Commission has the authority to cancel a telecommunications certificate, or in the present case, registration, pursuant to Section 392.410.5 RSMo, which provides “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”
4. The Company has failed to file its calendar year 2024 annual report. The requirement of an IVoIP company to file an annual report is identified in Sections 392.550.3(7), RSMo and Commission Rule 20 CSR 4240-28.012(1)(A). The Company has also failed to file its 2024 statement of revenue report and pay the

Missouri Commission annual assessment for fiscal year 2026.¹ The requirement to file a Statement of Revenue report is identified in Commission Rule 20 CSR 4240-28.012(1)(B). The requirement to pay the Missouri Commission assessment is identified in Section 386.370, RSMo and Commission Rule 20 CSR 4240-28.012(2)(A). The Company fails to be legally, financially, and technically qualified to provide service due it is dissolution in 2023. Therefore, Staff requests the Commission cancel the registration to provide IVoIP services in Missouri.

5. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests a hearing.²

WHEREFORE, Staff respectfully recommend the Commission cancel Next Level Internet, Inc.'s registration to provide IVoIP services in Missouri.

If a company fails to file a Statement of Revenue report then the company's assessment is calculated using a Commission approved formula.
