**MOTION TO CANCEL REGISTRATION OF OPERATING CERTIFICATE**

**COMES NOW** the Staff of the Missouri Public Service Commission (“Staff”) and moves for the Missouri Public Service Commission (“Commission”) to cancel the certificate of Authority to Resell Interexchange Telecommunications Services (“IXC”) within the State of Missouri of Working Assets Funding Service Inc., d/b/a Credo Long Distance, (“Credo” or “Company”) and states:

1. On February and May 18, 1993, in Case No. TA-93-159, the Commission granted Working Assets Funding Service Inc. d/b/a Working Assets Long Distance a Certificate of Service Authority to Resell Interexchange Telecommunications Services within the State of Missouri with the accompanying tariff P.S.C Mo. No. 1.

2. On November 9, 2007, the Commission recognized the name change of Working Assets Funding Service, Inc., d/b/a Working Assets Long Distance to Working Assets Funding Service, Inc., d/b/a Credo Long Distance.<sup>1</sup> The Commission also approved the adoption of tariff P.S.C. Mo. No. 1.<sup>2</sup>

3. On August 25, 2014, Credo filed a request with the Commission for “its long distance reseller Tariff No. 1 currently on file with the Commission be withdrawn

in its entirety effective September 18, 2014.” Credo’s tariff (Tracking No. YX-2008-0218), P.S.C Mo. No. 1, was cancelled as of September 18, 2014.

4. On October 12, 2022, Credo’s business registration expired with the Missouri Secretary of State for failure to comply with § 417.210 RSMo.

5. The Commission has the authority to cancel a telecommunications certificate pursuant to § 392.410.5 RSMo, which provides “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

6. The Company has failed to file its calendar year 2024 annual report. The requirement of a telecommunications company to file an annual report is identified in Sections 392.210 and 392.390, RSMo and Commission Rule 20 CSR 4240-28.012(1)(A). The Company has also failed to file its 2024 statement of revenue report and pay the Missouri Commission annual assessment for fiscal year 2026.<sup>3</sup> The requirement to file a Statement of Revenue report is identified in Commission Rule 20 CSR 4240-28.012(1)(B). The requirement to pay the Missouri Commission assessment is identified in Section 386.370, RSMo and Commission Rule 20 CSR 4240-28.012(2)(A). The Company fails to be legally, financially, and technically qualified to provide service due to its registration expiration in 2022. Therefore, Staff requests the Commission cancel the certificate to provide IXC service in Missouri.

If a company fails to file a Statement of Revenue report then the company’s assessment is calculated using a Commission approved formula.

7. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests a hearing.<sup>4</sup>

**WHEREFORE,** Staff respectfully recommend the Commission cancel Working Assets Funding Service Inc. d/b/a Credo Long Distance's certificate of authority to resell Interexchange Telecommunications Services service in Missouri.
