ORDER GRANTING MOTION FOR AN EXTENSION OF TIME TO FILE A STAFF RECOMMENDATION AND SETTING TIME FOR OTHER TARIFF RESPONSES

On March 1, 2026, the Liberty Utilities (Missouri Water) LLC d/b/a Liberty filed a motion stating that it was voluntarily extending the effective date of its proposed tariffs a second time to May 1, 2026. Liberty also requested that the Commission grant its Staff (Staff) until April 10, 2026, to file its tariff recommendation. In support of its motion, Liberty states that it is still discussing possible changes with Staff.

The Commission will grant Liberty's request. The Commission will also extend the time for other responses to Liberty's tariff sheets.

THE COMMISSION ORDERS THAT:

1. Liberty's motion for a Staff extension is granted. Staff shall file its recommendation regarding this matter no later than April 10, 2026.

2. Any other responses to Liberty's tariff sheets shall be filed no later than April 10, 2026.
