ORDER ESTABLISHING TIME TO RESPOND

On March 5, 2026, the Staff of the Commission (Staff) filed a motion requesting the Commission cancel the certificate of North County Communications Corporation to provide basic local exchange telecommunications service. The Commission granted North County Communications Corporation a certificate to provide basic local telecommunications service in Case No. TA-2001-399.

Staff's motion states that North County Communications Corporation was administratively dissolved by the Missouri Secretary of State's Office in 2019. The motion also states that North County Communications Corporation failed to file an annual report or statements of revenue for 2023 and 2024; and failed to pay the Commission assessment for fiscal year 2026.

The requirements of telecommunication companies under Sections 392.210 and 392.390, RSMo, include filing an annual report and a Statement of Revenue. Subsection 392.410(5), RSMo provides the Commission authority to alter or modify any telecommunications certificate of service after notice and hearing.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may revoke the telecommunications certificate based on Staff's motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to respond or file a motion for hearing.

THE COMMISSION ORDERS THAT:

1. Anyone wishing to respond to Staff's Motion or request a hearing shall do so by filing an appropriate pleading no later than March 16, 2026.
2. This order shall be effective when issued.
