Dear Judge Dippell:

In accordance with the Commission's *Report and Order* issued on January 14, 2026, approving and authorizing the terms of the Non-Unanimous Global Stipulation and Agreement and the Supplemental Stipulation and Agreement, Liberty submitted the "Paragraph 4 Sheets" containing the three sets of rates agreed-to by the signatories.

However, pursuant to the Supplemental Stipulation and Agreement, Liberty requests that the Commission issue an order suspending these tariff sheets. When the Staff of the Commission has concluded its review of a third consecutive month of satisfactory performance of the metrics, Staff will file a report describing its conclusions concerning the metrics and recommending that an order be issued authorizing the suspended rate and FAC tariff sheets to take effect as soon as is practicable.
