ORDER ESTABLISHING TIME TO RESPOND

Issue Date: March 6, 2026

Effective Date: March 6, 2026

On March 5, 2026, the Staff of the Commission (Staff) filed a motion requesting the Commission cancel the certificate of Working Assets Funding Service Inc. d/b/a Credo Long Distance to resell interexchange telecommunications services. The Commission granted Credo Long Distance that certificate in Case No. TA-93-159.

Staff's motion states that Credo Long Distance's business registration expired with the Missouri Secretary of State's Office in 2022. The motion also states that Credo Long Distance failed to file an annual report or statement of revenue for calendar year 2024; and failed to pay the Commission assessment for fiscal year 2026.

Subsection 392.410(5), RSMo provides the Commission authority to alter or modify any telecommunications certificate of service after notice and hearing. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, if no request for a hearing

or objection to Staff's motion is received, the Commission may revoke the telecommunications certificate based on Staff's motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to respond or file a motion for hearing.

THE COMMISSION ORDERS THAT:

1. Anyone wishing to respond to Staff's Motion or request a hearing shall do so by filing an appropriate pleading no later than March 16, 2026.
2. This order shall be effective when issued.
