ORDER DIRECTING NOTICE, SETTING DEADLINES FOR INTERVENTION AND RESPONSES, AND DIRECTING STAFF RECOMMENDATION

On March 6, 2026, Spire Missouri Inc. d/b/a Spire applied for an accounting authority order. Spire marked its application confidential in its entirety pursuant to Commission Rule 20 CSR 4240-2.135(2)(A), stating that it relates to market analysis or other market-specific information. Spire also requested a waiver of the 60-day notice requirement of Commission Rule 20 CSR 4240-4.017. Finally, Spire has requested expedited treatment of its application, requesting the Commission issue an order approving its application with an effective date no later than May 30, 2026.

The Commission will direct notice, set deadlines for entities to intervene and for parties to respond to Spire's application, and direct the Staff of the Commission (Staff) to review Spire's application and file a recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall send a copy of this order to the parties in Spire's latest general rate case – Case No. GR-2025-0107.
2. Any entity wishing to intervene in this matter shall file an application to intervene no later than March 23, 2026.
3. Staff shall review Spire's application and file a recommendation no later than April 8, 2026.

4. Any party wishing to respond to Spire's application shall do so no later than April 8, 2026.

5. This order is effective when issued.
