## NOTICE OF INTENT TO RESPOND AND REQUEST FOR ADDITIONAL RESPONSE TIME

COMES NOW Cintex Wireless, LLC ("Cintex" or "Company"), pursuant to 4 CSR 240-2.080(18), and hereby notifies the Commission of its intent to respond to the Addendum filed by Commission Staff on July 10, 2012 no later than July 26, 2012. In support hereof, Cintex states as follows:

- 1. On June 14, 2012, Staff filed its Complaint ("Complaint") and Motion for Order to Show Cause why the ETC Designation of Cintex Wireless, LLC Should Not be Provisionally Revoked ("Motion for Order to Show Cause"). The Commission on June 15, 2012 ordered that Cintex file its Answer no later than Monday, July 16, 2012. On June 20, 2012, the Commission ordered that Cintex file a pleading no later than Monday, July 16, 2012 showing cause why the Commission should not provisionally revoke its ETC designation ("Show Cause Order").
- 2. On July 10, 2012, Staff filed its Addendum to its Complaint and Motion for Order to Show Cause, in which it revised Count I and added Count V to its Complaint.
- 3. Cintex first received such Addendum, which Staff counsel mailed to Cintex, on this day, July 16, 2012. Cintex's Answer to Staff's initial Complaint and Response to the Commission's Show Cause Order are due on July 16, 2012.

- 3. As the Addendum was mailed to Cintex and not received until July 16, 2012, Cintex requests that it have ten (10) days, until July 26, 2012, pursuant to 4 CSR 240-2.080(18), from the date of receipt of the Addendum within which to file its Answer to Staff's Addendum.
- 4. Cintex has spoken with Staff counsel regarding its request to have until July 26, 2012 to file is Answer to Staff's Addendum, and Staff counsel has stated that it has no objection to such request.

WHEREFORE, Cintex hereby notifies the Commission of its intent to respond to Staff's Addendum and requests that the Commission grant it until July 26, 2012 to file such response.
