**STAFF RECOMMENDATION**

**COMES NOW** Staff of the Missouri Public Service Commission (“Staff”), and for its *Staff Recommendation* regarding Union Electric Company d/b/a Ameren Missouri’s (“Ameren Missouri”) tariff sheet, assigned Tracking No. JE-2026-0116, respectfully states as follows:

1. On March 2, 2026, Ameren Missouri submitted a revised tariff sheet, assigned Tracking No. JE-2026-0116 with an effective date of April 1, 2026, to true-up its Securitized Utility Tariff Charge and incorporate revised SUR calculations.
2. The submitted revised tariff sheet, PSC Mo. No. 6, 7th Revised Sheet No. 90.4, will supersede PSC Mo. No. 6, 6th Revised Sheet No. 90.4.
3. On March 4, 2026, the Commission issued an *Order Directing an Expedited Staff Tariff Recommendation and Setting Time for Tariff Objections or Comments* concerning Ameren Missouri’s proposed tariff revision, ordering Staff to file its recommendation on the tariff sheet no later than March 11, 2026. Any comments or objections must be filed no later than March 13, 2026.
4. As of the date of this filing, no comments or objections have been filed regarding Ameren Missouri’s proposed tariff revision.

5. Staff has reviewed Ameren Missouri's filing pursuant to the applicable statute, § 393.1700.2(3)(e), RSMo., and recommends the Commission approve the following tariff sheet, originally filed on March 2, 2026, to go into effect on and after April 1, 2026, the requested effective date:
