ORDER DIRECTING RESPONSES

On March 11, 2026, the Commission received a filing to discontinue a certificate to provide payphone telecommunications services from Jeffrey Faulkner d/b/a Mister Jeff's Hair Center (Faulkner). The filing included a single photograph of a payphone without further explanation.

Before the Commission acts on the requested cancellation, it will provide an opportunity for Faulkner to respond and will also direct the Staff of the Commission (Staff) to respond as described below.

Subsection 392.410(5), RSMo (2016), provides the Commission authority to alter or modify any telecommunications certificate of service after notice and hearing. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to Faulkner's filing is received, the Commission may revoke Faulkner's telecommunications certificate based on Faulkner's filing.

THE COMMISSION ORDERS THAT:

1. Faulkner, or anyone wishing to respond to this order shall do so no later than April 7, 2026. A response from Faulkner is not required.
2. Staff shall file a response to this order no later than April 14, 2026, regarding whether the certificate should be cancelled.
3. This order shall be effective when issued.
