ORDER CANCELLING CERTIFICATE OF SERVICE AUTHORITY

Issue Date: March 18, 2026

Effective Date: March 28, 2026

On March 5, 2026, the Staff of the Commission (Staff) filed a motion requesting that the Commission cancel the certificate of authority of Working Assets Funding Service Inc. d/b/a Credo Long Distance (“Company”) to resell interexchange telecommunications services in Missouri. The Commission granted the Company a certificate in Case No. TA-93-159. Staff’s motion stated that the Company’s business registration expired with the Missouri Secretary of State’s Office in 2022.

The requirements of telecommunication companies under Commission Rule 20 CSR 4240-28.012 and Sections 392.210 and 392.390, RSMo, (2016)¹ include filing a Statement of Revenue and filing annual reports. Staff’s motion states that the Company has not filed annual reports or Statement of Revenues as required by Commission rules.

The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5, RSMo, which provides “[a]ny certificate of service authority may be altered or modified by the commission after notice and

hearing...” The Commission issued notice and allowed time to request a hearing. No responses were received.

Based on Staff’s motion, the Company’s failure to file a Statement of Revenue or an annual report as required by rule, and because the Company has not requested a hearing or otherwise responded, the Commission finds that the certificate of service authority granted to Working Assets Funding Service Inc. d/b/a Credo Long Distance shall be cancelled.

THE COMMISSION ORDERS THAT:

1. The certificate of service authority issued in Case No. TA-93-159 to Working Assets Funding Service Inc. d/b/a Credo Long Distance to resell interexchange telecommunications services in the state of Missouri is cancelled.
2. This order shall become effective on March 28, 2026.
3. This case shall be closed on March 29, 2026.
