## ORDER CANCELLING CERTIFICATE OF SERVICE AUTHORITY

Issue Date: March 18, 2026

Effective Date: March 28, 2026

On March 5, 2026, the Staff of the Commission (Staff) filed a motion requesting that the Commission cancel the certificate of authority of Twin City Capital, LLC d/b/a American Select to provide interexchange telecommunications and non-switched local exchange telecommunications services. The Commission granted American Select a certificate to provide interexchange and non-switched local exchange telecommunications service in Case No. XA-2011-0110.

Staff's motion stated that American Select's fictitious name registration expired with the Missouri Secretary of State's Office in 2015. The motion also stated that American Select failed to pay the Commission assessment for fiscal year 2026.

The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5, RSMo, which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing..." The Commission issued notice and allowed time to request a hearing. No responses were received.

Based on Staff's motion, the American Select's failure to pay its annual assessment, the expiration of American Select's fictitious name registration, and

because American Select has not requested a hearing or otherwise responded, the Commission finds that the certificate of service authority granted to it shall be cancelled.

**THE COMMISSION ORDERS THAT:**

1. The certificate of service authority issued in Case No. XA-2011-0110 to Twin City Capital, LLC d/b/a American Select to provide interexchange and non-switched local exchange telecommunications services in the state of Missouri is cancelled.
2. This order shall become effective on March 28, 2026.
3. This case shall be closed on March 29, 2026.
