MOTION TO SUSPEND PROCEDURAL SCHEDULE

COMES NOW Union Electric Company, d/b/a Ameren Missouri (“Ameren Missouri”), on behalf of the parties to this case, and requests the Missouri Public Service Commission (“Commission”) suspend the procedural schedule in this case pending drafting and submission of a stipulation and agreement that will resolve all issues in this case, and in this regard, states as follows:

1. Certain parties have reached an agreement in principle on all contested issues in this case, and the remaining parties have indicated to the undersigned counsel that they will not oppose the stipulation and agreement reflecting those agreements. Consequently, once the formal stipulation and agreement is completed and filed, it will be treated as unanimous under 20 CSR 4240-2.115.
2. The procedural schedule currently calls for a settlement conference on March 19, 2026, and the filing of surrebuttal and cross-surrebuttal testimony on March 20, 2026. The agreement to resolve all issues dispenses with the need to participate in further settlement discussions and file surrebuttal/cross-surrebuttal testimony, as well as the rest of the procedural schedule thereafter.

3. Consequently, the parties request the Commission issue an order suspending the procedural schedule as soon as possible.

4. Counsel for all parties have authorized the undersigned counsel for Ameren Missouri to indicate that they support this Motion to Suspend Procedural Schedule.

WHEREFORE, Ameren Missouri, on behalf of the parties, respectfully requests the Commission issue an order suspending the procedural schedule as soon as possible.
