ORDER CANCELLING CERTIFICATE OF SERVICE AUTHORITY

Issue Date: March 19, 2026

Effective Date: March 29, 2026

On March 5, 2026, the Staff of the Commission (Staff) filed a motion requesting that the Commission cancel the certificate of authority of North County Communications Corporation to provide basic local exchange telecommunications service. The Commission granted North County Communications Corporation a certificate to provide basic local telecommunications service in Case No. TA-2001-399.

Staff's motion stated that North County Communications Corporation was administratively dissolved or had its business registration revoked by the Missouri Secretary of State's Office in 2019. The motion also states that North County Communications Corporation failed to file an annual report or statements of revenue for calendar years 2023 and 2024; and failed to pay the Commission assessment for fiscal year 2026.

The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5, RSMo, which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing..." The Commission issued notice and allowed time to request a hearing. No responses were received.

Based on North County Communications Corporation's failure to pay its annual assessment, failure to file annual reports and statements of revenue, the expiration of its business registration, and because North County Communications Corporation has not requested a hearing or otherwise responded, the Commission finds that the certificate of service authority granted to it shall be cancelled.

THE COMMISSION ORDERS THAT:

1. The certificate of service authority issued in Case No. TA-2001-399 to North County Communications Corporation to provide basic local exchange telecommunications service in the state of Missouri is cancelled.
2. This order shall become effective on March 29, 2026.
3. This case shall be closed on March 30, 2026.
