STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission and for its recommendation states:

- 1. In Case No. TA-98-124, the Commission granted BellSouth Long Distance, Inc. a certificate of service authority to provide basic local exchange and interexchange telecommunications services.
- 2. In Case No. XN-2007-0426 (Tariff File No. YX-2007-0793), the Commission granted the addition of a fictitious name, i.e., BellSouth Long Distance, Inc. to BellSouth Long Distance, Inc. d/b/a AT&T Long Distance Service. However, Staff notes that name change request only pertained to the company's interexchange tariff, P.S.C. Mo. No. 2.
- 3. On May 25, 2007, BellSouth Long Distance, Inc. filed adoption notices and revised tariff title sheets, with a proposed effective date of June 23, 2007, to reflect its change of corporate name to BellSouth Long Distance, Inc., d/b/a AT&T Long Distance Service. Tariff File No. YC-2007-0857 contains the filings for the company's MO P.S.C. No. 3, Local Exchange Telecommunications Service tariff.
 - 4. Commission rule 4 CSR 240-2.060 provides:
 - (5) A name change may be accomplished by filing the items below with a cover letter requesting a change of name. Notwithstanding any other provision of these rules, the items required herein may be filed by a nonattorney. Applications for approval of a change of name shall include:

- (A) A statement, clearly setting out both the old name and the new name;
- (B) Evidence of registration of the name change with the Missouri secretary of state; and
- (C) Either an adoption notice and revised tariff title sheet with an effective date which is not fewer than thirty (30) days after the filing date of the application, or revised tariff sheets with an effective date which is not fewer than thirty (30) days after the filing date of the application.
- 5. In the attached Memorandum, which is labeled Appendix A, the Staff recommends that the Commission recognize the new name. The application clearly sets out the old name of BellSouth Long Distance, Inc. and the new name of BellSouth Long Distance, Inc., d/b/a AT&T Long Distance Service. The application includes evidence of registration of the name change with the Missouri Secretary of State. The application includes an adoption notice and revised title sheet for each of the referenced tariffs.
- 6. Staff notes that officials of BellSouth Long Distance, Inc. notified Staff that no local exchange customers existed in Missouri, so notification regarding the name change was not necessary.

WHEREFORE, the Staff recommends that the Commission issue an order to recognize the name change of BellSouth Long Distance, Inc. to BellSouth Long Distance, Inc., d/b/a AT&T Long Distance Service, and to approve the adoption notices and revised tariff title sheets.
