SUBJECT: Staff's Amended Recommendation to Approve

DATE: June 5, 1997

On February 28, 1997, Friendship Village of West County (Friendship Village) submitted an application for a certificate of service authority to provide shared tenant service (STS). Notice of opportunity to intervene was issued March 4, 1997. Southwestern Bell Telephone Company (SWB) submitted an application to intervene on March 13, 1997. On March 26 and April 2, 1997, Friendship Village submitted a response and objection to SWB's application to intervene, and also submitted additional information regarding the facility proposed to be served by the STS. The additional information included a diagram and color picture of the facility. SWB submitted a Withdrawal of Application to Intervene on April 28, 1997.

Friendship Village, a Missouri corporation, is proposing to provide STS in Chesterfield, Missouri. The applicant provided copies of its Articles of Incorporation and Certificate of Incorporation from the Missouri Secretary of State. The applicant has agreed to abide by all Missouri Public Service Commission rules and regulations which are applicable to STS providers. If approved, Friendship Village would provide STS to a facility that consists of retirement apartments and nursing home. The facility is owned by Friendship Village.

On May 9, 1997, the Telecommunications Department Staff (Staff) prepared a Staff Recommendation to Approve for this application. On June 3, 1997, the Administrative Law Judge, Mr. Gregory George, requested an amended Staff recommendation to include the standard waivers for STS providers. In Case No. TA-96-283, the Commission ordered the Staff to prepare and file a standard list of waivers for STS providers. In that case, the Commission issued an Order Granting Waivers on July 31, 1996. This order established the standard list of waivers for STS providers as follows:

- 392.220 File tariffs with the Commission.
- 392.230 Charges for short and long distance service.
- 392.370(4) Submission of cost information.
- 392.370(5) Application of 392.220 and 392.230 for transitionally competitive services.
- 392.390(3) Separations reports.
- 392.500 Changes in rates.

- 932.270 Property valuation.
