**ORDER GRANTING EXTENSION TO SUBMIT PROPOSED
PROCEDURAL SCHEDULE**

On March 9, 2026,¹ the parties were directed to submit a proposed procedural schedule no later than March 23. On March 23, the Staff of the Commission (Staff) timely filed its *Motion for Extension* (Motion).

The Motion states that the parties have not yet reached consensus on a proposed procedural schedule. The Motion, therefore, requests an extension for the parties to file a proposed procedural schedule no later than March 27. The Motion indicates that all other parties were consulted and none objected to the extension.

The Commission finds the requested extension to be reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff’s request for an extension of time is granted. The parties shall submit their proposed procedural schedule, jointly if possible, no later than March 27, 2026.
