PROPOSED LOCAL PUBLIC HEARING SCHEDULE

As noted in its earlier Joint Proposed Procedural Schedule, with the local public hearings during the week of July 14-17, the Company must have the Commission approval of the bill insert no later than Wednesday, May 13, 2026, so that the insert can be timely inserted into customer bills in the billing cycle in advance of the local public hearings.
