ORDER OF RULEMAKING

By the authority vested in the Public Service Commission under sections 386.040, 386.250, 386.310, 393.140, 393.130 and 394.160 RSMo 2000, the commission adopts a rule as follows:

4 CSR 240-18.010 is amended.

A notice of proposed rulemaking containing the text of the proposed rule was published in the *Missouri Register* on June 16, 2008 (33 MoReg 1134). This proposed rule will become effective thirty (30) days after publication in the *Code of State Regulations*.

SUMMARY OF COMMENTS: A public hearing on the proposed amendments was held July 16, 2008, and the public comment period ended July 16, 2008. One written comment was received from the Staff of the Public Service Commission, and the only person to testify at the hearing was Staff witness David Elliott.

COMMENT: Mr. Elliot supports adoption of the amendment but notes that the Missouri Register contained a typographical error in the sentence following the title, which indicated the addition of section (5), but should have referred to section (4), as there is no section (5). However, as this sentence only appears in the Register to assist readers and is not included in the Code of State Regulations, no change is required.

RESPONSE: No language change is necessitated by this comment.
