**RESPONSE OF CO-MO ELECTRIC COOPERATIVE, INC.
TO THE APPLICATION OF DAVE EVERSOLE
FOR CHANGE OF ELECTRIC SERVICE PROVIDER**

COMES NOW Co-Mo Electric Cooperative, Inc. (“Co-Mo”) by and through its undersigned counsel, and for its Response to the Application of Dave Eversole (“Applicant”) for Change of Electric Service Provider, pursuant to the Missouri Public Service Commission’s (“Commission”) Order Directing Notice and Directing Responses to Application (“Order”) issued on March 2, 2026 and, in support thereof, states as follows:

1. On February 27, 2026, Dave Eversole (the “Customer” or “Applicant”) filed an Application for Change of Electric Service Provider (“Application”) with the Commission, requesting a change from Union Electric Company d/b/a Ameren Missouri to Co-Mo Electric Cooperative, Inc. (“Co-Mo”) for 17651 & 17601 B Highway, Boonville, Missouri 65233 (the “Property”).
2. On March 2, 2026, the Commission issued an Order directing Co-Mo to file a response to the Application no later than April 1, 2026.
3. Co-Mo takes no position on the sufficiency of the Application. Co-Mo requests the Commission approve Applicants’ request as Co-Mo is able to serve the Property and this property is within the exclusive service territory of Co-Mo, for new structures, under the terms and conditions outlined in the Territorial Agreement dated May 22, 2022 (Case No. EO-2022-0332).

4. In response to Applicant's Paragraph 6, Co-Mo has been engaged in communication with Applicant regarding new service and line extension design. Co-Mo currently has existing lines on the Southwest corner of the Property from which it can provide electric service.
5. If Ordered to serve this location by the Commission, Co-Mo is ready, willing and able to so serve.
6. Co-Mo is without knowledge to confirm or deny the remaining allegations of the Application.
