**ORDER GRANTING EXTENSION TO SUBMIT  
PROPOSED PROCEDURAL SCHEDULE**

On March 9, 2026,<sup>1</sup> the parties were directed to submit a proposed procedural schedule no later than March 23, extended to March 27 and again to April 1. On April 1, the Staff of the Commission (Staff) timely filed its *Motion for Extension* (Motion).

The Motion states that the parties are continuing discussions regarding a proposed procedural schedule. The Motion, therefore, requests an extension for the parties to file a proposed procedural schedule no later than April 3.

The Commission finds the requested extension to be reasonable and will grant it.

**THE COMMISSION ORDERS THAT:**

1. Staff's request for an extension of time is granted. The parties shall submit their proposed procedural schedule, jointly, if possible, no later than April 3, 2026.
2. This order shall be effective when issued.

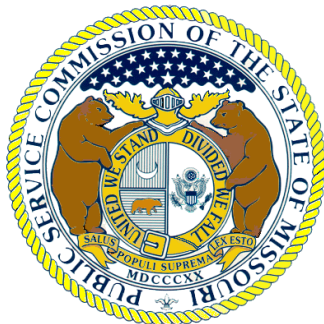
