**ORDER DIRECTING STATUS REPORT**

Issue Date: April 8, 2026

On April 2, 2026, Show Me Ethanol filed a *Status Report and Motion* on behalf of the parties requesting additional time to file a proposed schedule. The status report states that Show Me Ethanol has engaged a third-party to aid in investigation of service reliability issues.

The motion requests that the Commission relieve its Staff (Staff) of the duty to file further status report. It also requests that the Commission grant until May 4, 2026, to file a further status report or procedural schedule.

There is currently no deadline to resolve this complaint, and the parties are collectively attempting to address the underlying issues. Therefore, the Commission will direct that the parties file a joint Status report no later than July 15, 2026. If the parties need the Commission to address anything in this case prior to that date, they shall file a pleading. The Commission also will relieve Staff of the duty to file further status reports.

**THE COMMISSION ORDERS THAT:**

1. Staff is relieved of the duty to file further status reports on behalf of the parties.

2. The parties shall file a joint status report no later than July 15, 2026, informing the Commission of the complaint's status.

3. This order is effective when issued.

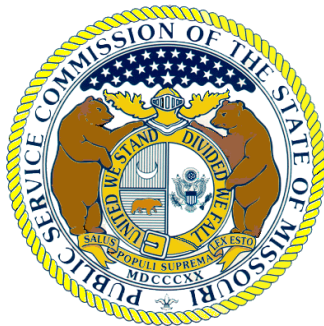
