Re: Everstream Solutions LLC request to withdraw Certificate of Service Authority to Provide Basic Local Exchange Telecommunications Services, File No. CA-2020-0038

Ms. Dippell,

Everstream Solutions LLC., (“Everstream”) requests authority to withdraw its Certificates of Service to Provide Basic Local Exchange Service and to cancel any related tariffs. In support, Everstream states:

1. On Aug. 22, 2019, the Missouri Public Service Commission (“Commission”) granted Everstream a Certificate of Service Authority to Provide Basic Local Exchange Telecommunications Services in CA-2020-0038.

3. On Sept. 30, 2024, Everstream completed the sale of substantially all its assets in the State of Missouri to Unite Private Networks (“Segra”).¹

4. On May 28, 2025, Everstream and its affiliated debtors filed a petition for relief under Chapter 11 of Title 11 of the United States Code (the “Bankruptcy Code”) in the United States Bankruptcy Court for the Southern District of Texas, Houston Division (the “Bankruptcy Court”).

5. The filing included a Stalking Horse agreement to sell substantially all Everstream assets, excluding those sold to Segra and Everstream's Pennsylvania network, ("WholeCo assets"), to Bluebird Fiber Networks, LLC.² The Agreement included assets in Missouri not sold to Segra.

6. On March 6, 2026, Everstream completed the sale of its WholeCo assets to Bluebird and emerged from bankruptcy.³

7. Following emergence from bankruptcy, Everstream no longer has any customers, facilities or operations in the State of Missouri and will cease operations.

8. Everstream now seeks to abandon and withdraw its Certificate of Service Authority to Provide Basic Local Exchange Telecommunications Services, File No. CA-2020-0038.


Wherefore, Everstream requests that the Commission: (i) withdraw Everstream's certificates of local exchange and interexchange service authority; and (ii) cancel and annul its tariffs on file with the Commission.
