ORDER CANCELLING PAYPHONE CERTIFICATE OF SERVICE

Issue Date: April 14, 2026

Effective Date: April 24, 2026

On March 11, 2026, the Commission received a filing to cancel a certificate to provide payphone telecommunications services from Jeffrey Faulkner d/b/a Mister Jeff's Hair Center (Faulkner). Faulkner was granted its payphone certificate of authority in Case No. PA-2004-0137.

The Commission directed the Staff of the Commission (Staff) to respond as Faulkner's filing consisted of a photograph of a payphone. Staff responded that it understood from conversations with Faulkner representatives that Faulkner no longer uses the payphone at issue. Thus, Staff supports the cancellation request. The Commission also set a time for other responses, but none were received.

Commission Rule 20 CSR 4240-28.011(3) permits a company to cancel a certificate of service authority by filing a letter signed by a company official that identifies when and which certificate to cancel. Based on the request of Faulkner and Staff's response, the Commission finds that certificate of authority granted to it to provide payphone telecommunications services in Missouri shall be cancelled.

THE COMMISSION ORDERS THAT:

1. The certificate of authority to provide payphone telecommunications services, granted to Jeffrey Faulkner d/b/a Mister Jeff's Hair Center in Case No. PA-2004-0137, is cancelled.
2. This order shall become effective on April 24, 2026.
3. This case shall be closed on April 25, 2026.
