ORDER CANCELLING CERTIFICATE OF SERVICE AUTHORITY

Issue Date: April 14, 2026

Effective Date: April 24, 2026

On April 1, 2026, the Staff of the Commission (Staff) filed a motion requesting that the Commission cancel the certificate of service authority of Convergia, Inc. to provide intrastate interexchange telecommunications service. The Commission granted Convergia a certificate to provide intrastate interexchange telecommunications service in Case No. XA-2003-0246. Convergia also has a currently effective tariff assigned Tracking No. YX-2003-1366.

Staff's motion states that Convergia failed to pay the Commission assessment for fiscal year 2026. Payment of the assessment is required pursuant to Section 386.370.3, RSMo (Supp. 2025), and Commission Rule 20 CSR 4240-28.012(2)(A).

The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5, RSMo, which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing..." The Commission issued notice and allowed time to request a hearing.

No responses were received. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹

Based on Staff's motion, Convergia's failure to pay its annual assessment, and because Convergia has not requested a hearing or otherwise responded, the Commission finds that the certificate of service authority granted to it shall be cancelled.

THE COMMISSION ORDERS THAT:

1. The certificate of service authority issued in Case No. XA-2003-0246 to Convergia, Inc. to provide intrastate interexchange telecommunications services in the state of Missouri is cancelled.
2. Convergia, Inc.'s tariff, Tracking No. YX-2003-1366, is cancelled.
3. This order shall become effective on April 24, 2026.
4. This case shall be closed on April 25, 2026.
