**ORDER DIRECTING NOTICE, SETTING INTERVENTION DEADLINE,
AND DIRECTING FILING OF STAFF RECOMMENDATION**

On April 14, 2026, LTE Wireless Inc. applied for designation as an Eligible Telecommunications Carrier (ETC) in the state of Missouri. Specifically, LTE Wireless stated it seeks ETC designation for purposes of receiving federal and state Lifeline and Disabled Support. LTE Wireless requested ETC designation statewide. LTE Wireless also requested waiver of the Commission’s 60-day notice of case filing requirement.

Notice of the application shall be sent to all incumbent and competitive local exchange carriers certificated to provide service in Missouri. The Commission will also set a deadline for intervention requests and will direct the filing of a recommendation by the Staff of the Commission (Staff).

THE COMMISSION ORDERS THAT:

1. The Commission’s Data Center shall send notice of this application to all eligible telecommunications carriers certificated to provide service in Missouri.
2. Any request to intervene shall be filed with the Commission no later than April 30, 2026. Such applications shall be filed with:

3. Staff shall file a recommendation regarding this application, or a request for an extension of time, no later than May 14, 2026.

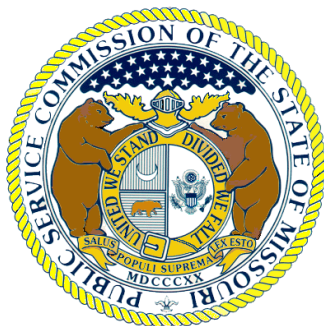
