ORDER DIRECTING RESPONSE

On March 16, 2026, Pernell Robinson, Jr. (Complainant) filed a complaint with the Commission against Spire Missouri Inc. d/b/a Spire. The complaint avers that Spire violated the Cold Weather Rule.

On April 15, 2026, Spire filed its *Motion for Summary Determination* (Motion) with an attached memorandum of law in support. The Motion seeks a summary determination on the grounds that there is no genuine dispute as to the material facts in this case.

The Commission will order the Complainant to respond and will also allow other responses. The Commission will set the response time pursuant to 20 CSR 4240-2.117(1)(C).

As the date for responses to the Motion coincides with the due date for the Staff of the Commission (Staff) to file its report and recommendation, the Commission will extend the time for Staff to file its report by one week.

THE COMMISSION ORDERS THAT:

1. Pernell Robinson, Jr. shall file a response to Spire's Motion for Summary Determination no later than May 15, 2026.
2. Any other party wishing to file a response to the motion for summary determination shall do so on or before May 15, 2026.
3. Staff's investigation and report shall be filed no later than May 22, 2026.
4. This order shall be effective when issued.
