On April 20, 2026, Spire Missouri Inc. d/b/a Spire filed an application for a certificate of convenience and necessity (CCN) to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system in Christian County, Missouri. In its application, Spire also requests waiver of the Commission’s rule requiring 60 days’ notice prior to filing an application.<sup>1</sup>

The Commission will direct notice of the application be given to the Christian County Commission and local media. The Commission will set a deadline for interested parties to intervene and direct its Staff to file a recommendation regarding the application.

**THE COMMISSION ORDERS THAT:**

1. The Commission’s Data Center shall provide a copy of this order and the application to the County Commission of Christian County, Missouri.
