ORDER DIRECTING RESPONSE TO MEDIATION REQUEST

Issue Date: April 23, 2026

Effective Date: April 23, 2026

On March 23, 2026, Micha Davis filed a complaint with the Commission against Union Electric Company d/b/a Ameren Missouri. On March 24, 2026, the Commission issued its *Order Giving Notice of Case Filing, Directing Answer, and Directing Staff Investigation*, which also mentioned the possibility of mediation.

Mediation is an informal method of dispute resolution in which the parties voluntarily agree to participate. No party relinquishes any rights by agreeing to participate in mediation.

On April 21, 2026, Ameren Missouri filed a *Request for Mediation*, which stated its desire to mediate the complaint.

The Commission will direct Ms. Davis to file a response stating whether she agrees to mediation of her complaint.

THE COMMISSION ORDERS THAT:

1. No later than May 7, 2026, Ms. Davis shall file a response to Ameren Missouri's mediation request, stating whether she agrees to enter into mediation.

2. All other actions on this case shall cease and all time limitations and previously ordered deadlines are tolled until the Commission rules on Ameren Missouri's meditation request.

3. This order is effective when issued.
