ORDER APPOINTING MEDIATOR AND STAYING DEADLINES

Issue Date: April 28, 2026

Effective Date: April 28, 2026

Complainant, Micha Davis, filed a complaint with the Commission against Union Electric Company d/b/a Ameren Missouri. On April 21, 2026, Ameren Missouri requested mediation. Complainant agreed to participate in mediation in a response filed on April 28, 2026. The Commission will appoint a mediator, stay previously-ordered procedural deadlines, and toll time limitations.

On April 28, 2026, in a separate filing, Complainant filed a *Motion to Remove Case from Small Formal Complaint Procedure and Proceed Under Standard Formal Rules*, alleging that Ameren Missouri’s actions described in the complaint resulted in a financial impact exceeding \$3,000. The Commission will grant Complainant’s motion.

THE COMMISSION ORDERS THAT:

1. Ron Pridgin, Deputy Chief Regulatory Law Judge with the Commission, is appointed as mediator, pursuant to Commission Rule 20 CSR 4240-2.125(2)(B).

2. All procedural deadlines are stayed and all time limitations are tolled pending completion of the mediation process.

3. This case will no longer proceed under the small formal complaint procedure of Commission Rule 20 CSR 4240-2.070(15).

4. This order is effective when issued.
