1 P R O C E E D I N G S

2 JUDGE WOODRUFF: All right. Let's go
3 ahead and go on the record. Welcome, everyone.
4 We're here for a rule-making hearing regarding a
5 proposal to amend Chapter 4 CSR 240-18.010, which
6 is a proposed amendment to adopt the 2012 edition
7 of the National Electrical Safety Code.

8 This proposed amendment was published in
9 the Missouri Register on September 3rd, and notice
10 was given of this hearing at that time.

11 And it is now approximately 10:03 a.m.,
12 and we are in the assigned room, which is Room 305
13 of the Commission's office here in Jefferson City.

14 We have -- Staff is present in the person
15 of Nathan Williams. And, Mr. Williams, do you wish
16 to make any comments?

17 MR. WILLIAMS: Yes. Staff filed comments
18 on -- let's see -- actually, two days ago on
19 October 2nd suggesting that the Commission modify
20 the amendment to add a second errata sheet -- or I
21 shouldn't say errata sheet.

22 It's actually a series of sheets. But
23 second edition of erratas to the proposed rule for
24 the adoption of the National Elec -- portions of
25 the National Electric Safety Code into the rule.

1 It turns out that that second errata sheet is
2 actually duplicative of the first, plus, has
3 additional corrections so that the Commission
4 could, instead of adding an additional -- the
5 additional set of errata sheets just update it from
6 the February 6th, 2012, errata -- set of errata
7 sheets to the April 29th, 2013, errata sheets.

8 That's all of Staff's comments. Allen Bax
9 is here if the Commission wants to inquire any
10 further as to the National Electric Safety Code or
11 the errata sheets.

12 JUDGE WOODRUFF: Okay. So in looking at
13 your -- the last page of your written comments, we
14 would just -- you're suggesting we just delete the
15 February 6th, 2012, and replace it with the April
16 29 --

17 MR. WILLIAMS: 2013. Right.

18 JUDGE WOODRUFF: 2013. Okay.

19 MR. WILLIAMS: Either would do it. But
20 you'd have a set of -- a reference to a set of
21 errata sheets that wouldn't add new information.

22 JUDGE WOODRUFF: Okay. Anything else
23 Staff wishes to comment about?

24 MR. WILLIAMS: No.

25 JUDGE WOODRUFF: All right. Anyone else

1 in the room wishing to comment? I don't see any
2 other hands go up. So at this time, we will
3 adjourn this proceeding. Thank you very much.

4 MR. WILLIAMS: Thank you.

5 MR. BAX: Thank you, Judge.

6 (The proceedings were concluded at 10:03 a.m. on
7 October 4, 2013.)
