On May 7, 2026, Missouri-American Water Company (MAWC) submitted an application requesting authorization to issue up to \$750 million in long-term debt. MAWC also requested waiver of the 60-day notice requirement under Commission Rule 20 CSR 4240-4.017.

The Commission will direct the Staff of the Commission (Staff) to file a recommendation regarding MAWC’s application or a status report regarding when it expects to file the recommendation.

1. No later than June 22, 2026, Staff shall file a recommendation regarding MAWC’s application or a status report regarding when it expects to file its recommendation.
2. This order shall be effective when issued.
