ORDER CANCELING DISCOVERY CONFERENCE

On April 2, 2026, the Commission issued its *Order Setting Procedural Schedule*. That order set a discovery conference for May 13, 2026. The order required that any party with a discovery concern must file a brief statement describing that concern at least three business days before each discovery conference. If no party identifies any discovery concerns the presiding officer may cancel that conference. No party has identified any discovery concerns. Therefore, the Regulatory Law Judge is canceling the discovery conference.

1. The May 13, 2026, discovery conference is canceled.
