STAFF TARIFF RECOMMENDATION

COMES NOW Staff of the Missouri Public Service Commission and for this *Staff Tariff Recommendation* respectfully states as follows:

1. On April 24, 2026, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) filed tariff revisions, bearing Tracking No. JE-2026-0130, with an effective date of June 1, 2026.

2. On April 27, 2026, the Commission issued its *Order Directing a Staff Tariff Recommendation and Setting Time for Other Tariff Responses*. The Commission ordered Staff to file a recommendation addressing Ameren Missouri's tariff revisions no later than May 12, 2026.

3. Staff has reviewed the tariff revisions filed in Tariff Tracking No. JE-2026-0130 and recommends the Commission approve them with an effective date of June 1, 2026, as requested by Ameren Missouri.

EXECUTIVE SUMMARY

On April 24, 2026, Union Electric Company d/b/a Ameren Missouri filed tariff revisions, Tracking No. JE-2026-0130, with an effective date of June 1, 2026. The submitted tariff sheets revised for the Company's 1M, tariff sheets PSC MO Schedule No. 6.

On April 27, 2026, the Commission filed its Order Directing a Staff Tariff Recommendation and Setting Time for Responses, ordering Staff to file its recommendation no later than May 12, 2026.

BACKGROUND

On April 23, 2025, the Commission approved the Stipulations and Agreements in ER-2024-0319. Included in that Commission approval was the Stipulation and Agreement filed on March 14, 2025, where Ameren Missouri was required to:

50. Ameren Missouri will implement Evergy's approach (agreed upon in File No. ER-2024-0189) to integrating time-of-use rates for net-metered customers, as follows:

a. Ameren Missouri shall implement tariff changes in its Tariff Sheet Nos. 171 and 171.11 (with sheet numbers potentially revised due to shifting of content as a result of the additions) consistent with the attached exemplar tariff.

b. The revised tariff effective date and billing capabilities are to be completed not later than one year from the effective date of rates set in this case.

STAFF REVIEW

The substitute tariff sheets revise language to allow residential net metering customers to be able to participate in other residential time of use rate options.

STAFF RECOMMENDATION

Staff recommends the Commission approve the following tariff sheet, as filed on April 24, 2026, to go into effect on June 1, 2026:


