**ORDER DIRECTING NOTICE, SETTING INTERVENTION DEADLINE, AND
DIRECTING STAFF RECOMMENDATION**

On May 14, 2026, Evergy Metro, Inc. d/b/a Evergy Missouri Metro filed the above-referenced application with the Commission seeking an order granting a Certificate of Convenience and Necessity (CCN) to construct a 440 MW simple-cycle gas turbine electric generating facility in Nodaway County, Missouri.

The Commission will provide notice of the application to the general public and interested parties, set a deadline for intervention requests, and direct the Staff of the Commission (Staff) to provide a recommendation regarding the application.

THE COMMISSION ORDERS THAT:

1. The Commission’s Data Center shall provide a copy of this order to the County Commission of Nodaway County, Missouri.

2. The Commission’s Public Policy and Outreach Department shall provide notice of this application to news media outlets serving the residents of Nodaway County, Missouri.

3. Any person or entity wishing to intervene in this matter shall file an application to intervene no later than May 29, 2026. The application shall be filed in the Commission's Electronic Filing and Information System (EFIS) or with the Secretary of the Commission.

4. Staff shall file a recommendation regarding Evergy Missouri Metro's application, or a request for additional time in which to file a recommendation, no later than June 29, 2026.

5. This order shall be effective when issued.
