## ORDER CANCELLING REGISTRATION

Issue Date: May 18, 2026

Effective Date: May 28, 2026

On May 5, 2026, AccessLine Communications Corporation (ACC) filed a letter notifying the Commission that it no longer wished to retain its certificate of authority to provide interexchange telecommunications services in Missouri. ACC was granted its certificate of authority in Case No. XA-2007-0467.

The letter stated that ACC does not offer or provide any intrastate telecommunications services to Missouri customers pursuant to its certificate, and requested the cancellation be effective on May 19, 2026. ACC also requested cancellation of its currently effective tariff, Tracking No. YX-2015-0134.

Commission Rule 20 CSR 4240-28.011(3) permits a company to cancel a certificate of service authority by filing a letter signed by a company official that identifies when and which certificate to cancel along with specifying any applicable tariffs that should be cancelled. Based on the request of ACC, the Commission finds that certificate of authority granted to it to provide interexchange telecommunications services in Missouri shall be cancelled as well as its related tariff.

The Commission finds it reasonable to allow this order to become effective in less than 30 days.<sup>1</sup>

**THE COMMISSION ORDERS THAT:**

1. The certificate of authority to provide interexchange telecommunications services, granted AccessLine Communications Corporation in Case No. XA-2007-0467, is cancelled.
2. AccessLine Communications Corporation's interexchange tariff, assigned Tracking No. YX-2015-0134, is cancelled.
3. This order shall become effective on May 28, 2026.
4. This case shall be closed on May 29, 2026.
