On April 28, 2026, Stimulus Technologies of Missouri, LLC d/b/a Stimulus Technologies, pursuant to Section 392.550, RSMo, filed an application for registration to provide Basic Local Exchange (CLEC) Telecommunications Services in the following exchanges:

Statewide

The Commission has reviewed the application and finds that it and the attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo.¹ The affidavit attached to the application represents that the company has not had contact with the office of the Commission about any substantive issue connected to the filing.

This order will be issued with less than a 30-day effective date to comply with Section 392.550, RSMo.

¹ Subsection 392.611.4, RSMo, states that “[a]fter August 28, 2014, telecommunications companies seeking to provide telecommunications service may, in lieu of the process and requirements for certification set out in other sections, elect to obtain certification by following the same registration process set out in subsection 3 of section 392.550”

THE COMMISSION ORDERS THAT:

1. Stimulus Technologies of Missouri, LLC d/b/a Stimulus Technologies is registered and granted certification to provide CLEC Telecommunications Services in the exchanges set forth in the affidavit attached to the application and restated above.
2. This order shall become effective on May 29, 2026.
3. This case shall be closed on May 30, 2026.
