Re: Notification of K.L.M. Telephone Company, LLC Regarding a Change in Legal Name and Use of Fictitious Name

Dear Secretary Dippell:

K.L.M. Telephone Company, LLC (formerly K.L.M. Telephone Company) ("K.L.M. Telephone") hereby notifies the Missouri Public Service Commission of a change in corporate form from a Missouri corporation to a Missouri limited liability company that resulted in a legal name change from "K.L.M. Telephone Company" to "K.L.M. Telephone Company, LLC" (the "Conversion"). Additionally, K.L.M. Telephone notifies the Commission of its intent to conduct business in Missouri under the fictitious name "Socket Fiber".

In Missouri, K.L.M. Telephone holds a Certificate from the Commission to operate as an incumbent local exchange carrier, granted in Docket No. TA-88-61 on September 18, 1987.¹

The Conversion was completed by filing the required documentation with the Missouri Secretary of State, provided herewith as **Attachment A**, and did not disrupt the existence of K.L.M. Telephone. As such, K.L.M. Telephone is the same entity as it was prior to the Conversion, except that it is now a Missouri limited liability company rather than a Missouri corporation.²

² Under Missouri corporate law, "[w]hen a corporation has been converted to another entity or business form under this section, the other entity or business form shall, for all purposes of the laws of the state of Missouri, be deemed to be the same entity as the corporation." The Conversion does not affect the rates, terms or conditions of service provided by K.L.M. Telephone. Customers continue to be served by the same entity from which they previously obtained service and continue to receive invoices for services from K.L.M. Telephone under the same contracts, rates, terms and conditions of service as before the Conversion.

Following completion of the Transaction and the Conversion, K.L.M. Telephone intends to conduct business in Missouri under the fictitious name "Socket Fiber". The Registration of Fictitious Name filed with the Missouri Secretary of State is herewith as **Attachment B**.

K.L.M. Telephone requests that the Commission update its records, including K.L.M. Telephone's Certificate, to reflect the change in legal name resulting from the Conversion. Provided as **Attachment C** are a one-page tariff adoption notice and updated title page for K.L.M. Telephone's PSC Mo. No. 1 reflecting the legal name change and new fictitious name. K.L.M. Telephone will separately review and update its contacts in EFIS as necessary.

Pursuant to the provisions of Section 392.030 of the Missouri Telephone Companies Act, K.L.M. Telephone Company, a Missouri corporation (the "Corporation"), possesses all of the powers and privileges granted to corporations by Chapter 351 of the General and Business Corporation Law of Missouri (the "Act"). Pursuant to the provisions of Section 351.409 of the Act, the Corporation, hereby certifies as follows relating to the conversion to K.L.M. Telephone Company, LLC, a Missouri limited liability company (the "LLC"):

1. The name of the Corporation is K.L.M. Telephone Company.
2. The Corporation was formed as a Missouri corporation on January 17, 1955.
3. The Corporation elects to become a Missouri limited liability company.
4. The conversion of the Corporation into the LLC has been approved by the Corporation in the manner provided for under Section 351.409(2) of the Act.
5. The Articles of Organization of the LLC attached hereto as Exhibit A shall be the articles of organization of the limited liability company formed pursuant to such election and the name as set forth in its Articles of Organization shall be K.L.M. Telephone Company, LLC.
6. Upon the effective date of the conversion, all of the shares held by the sole shareholder of the Corporation shall, by virtue of the conversion and without any action on the part of such shareholder, be converted into one hundred percent (100%) of the membership interests of the LLC. At the conclusion of the conversion, the ownership of the LLC shall be identical to the ownership of the Corporation immediately prior to the conversion.
7. As a result of the conversion, at the Effective Date, all shares of the Corporation shall cease to be outstanding, shall be canceled and retired and shall cease to exist, and the Corporation's sole shareholder shall thereafter cease to have any rights with respect to such shares, except the right to retain one hundred percent (100%) of the membership interests of the LLC.
8. The Corporation agrees that it may be served with process in the State of Missouri in any proceeding for enforcement of any obligation of the corporation arising while it was a corporation of this state, and that it irrevocably appoints the Secretary of State of Missouri as its agent to accept service of process in any such action, suit or proceeding.
