JOINT MOTION TO ESTABLISH PROCEDURAL SCHEDULE

COME NOW the Staff of the Missouri Public Service Commission, the Heart of America United Way, Inc. (HAUW), the Office of the Public Counsel (OPC), and the Intervenors Green Hills Telephone Corporation, Citizens Telephone Company of Higginsville, Missouri, Cass County Telephone, Lathrop Telephone and KLM Telephone Company and for their joint motion state:

1. On July 11, 2003, HAUW filed an Application requesting the Commission to designate HAUW as the holder of the 2-1-1 dialing code for access to community information and referral services in certain exchanges.

2. On March 2, 2004, the Commission scheduled a prehearing conference for March 9, 2004, and directed the parties to file a proposed procedural schedule no later than March 16, 2004.
