The Commission finds that amending and rescinding the rules is necessary to protect the public interest and to carry out the purposes of the statutes that granted the rulemaking authority. The Commission will seek comments from interested stakeholders during the rulemaking process.

1. The Secretary of the Commission shall file the proposed amendments and rescission to the above-listed rules with the Secretary of State for publication in the Missouri Register as a proposed rulemaking.
2. This order shall be effective when issued.
